

AIM TO KILL STALIN LAID TO GEORGIANS

Two Attempts to Assassinate Dictator Described in Trial of 13 for Treason

FIRING AT HIS BOAT FAILED

Effort to Ambush Leader Also Made—23 More Doomed in Various Parts of Russia

MOSCOW, Nov. 3.—Another big treason case in which forty-seven persons accused of varying counter-revolutionary crimes, including two vain attempts to assassinate Joseph Stalin, is under way in Sukhumi.

Mikhail Lakoba is quoted as telling NKVD investigators that he was visited last March by an agent of a foreign power with whom Nestor had collaborated. He quoted this agent as saying: "There will soon be a war between the U.S.S.R. and Germany. If you would like to do something to avenge the death of Nestor Lakoba and would like to kill some party or government leader, go ahead and do it. I will get you a foreign passport and we will escape together."
